## Program

A unique feature of this program is your active participation in a community of practice (CoP), conceptualized as a collaborative, dynamic, active learning group. Students must successfully complete the following degree requirements:

- 1.5 coursework credits in: Social Practice and Transformational Change; Methodologies Lab, Critical Community Engaged Scholarship
- Qualifying Examination
- Thesis

The program can also be taken with the International Development Studies or the Sexualities, Genders, and Bodies collaborative specializations.

## Key Pillars

The proposed program is grounded by six key pillars:

- Intersectional and Decolonizing Approaches and the 'Unsettling' Nature of Change
- Feminist, Gender, Sexuality and Other Critical Perspectives for Rethinking Difference and the Human
- Indigenous Knowledge Systems
- Social Justice and Praxis Orientation
- Methodological Innovation and Boundary Crossing
- Community Engaged Scholarship



## Admission Requirements

Successful completion of a course or thesis-based master's degree with a minimum grade average of at least 78% from an accredited university. Applicants who have not completed a master's degree but have considerable relevant professional experience outside the academy may be considered for direct entry into the doctoral program. If relevant, a portfolio of prior work that connects to your research interest may be required. This could include policy, scholarly, or community activities.

## Funding

The program is committed to providing a minimum stipend of \$20,000 for all students. Students are guaranteed financial support through teaching assistantships, research assistantships, and/or scholarships.
